NOTES

1. This appeal procedure relates to Reduced Pollution Tests carried out for first issue or renewal of Reduced Pollution Certificates or for tests carried out to clear Reduced Pollution Rectification Notices. If however you wish to complain against the issue of a Reduced Pollution Rectification Notice (RPC5) you should refer to your local Road Traffic Enforcement Area Office. Information regarding addresses and telephone numbers of the appropriate local office is available at Vehicle and Operator Services Agency main offices or at your local Goods Vehicle Testing Station.
2. An appeal against a refusal to issue a Reduced Pollution Certificate after a Reduced Pollution Test will be considered if this form is fully completed and is received at VOSA within 14 days of the date of issue of a Notification of Refusal to Issue a Reduced Pollution Certificate. Send this form to Vehicle and Operator Services Agency, Testing & Support Services (RPC), Ellipse, Padley Road, SWANSEA SA1 8AN and **NOT** direct to your local Goods Vehicle Testing Station. You will be contacted and arrangements made for an appeal test at a mutually convenient time and place, wherever possible.
3. No fee is payable for an appeal against a refusal to issue a Reduced Pollution Certificate.
4. Please ensure that you retain the copy (copies) of the Notification(s) of Refusal to Issue a Reduced Pollution Certificate against which you are appealing and take it (them) with you for inspection at the appeal test together with any unexpired Reduced Pollution Certificates you already hold in respect of the vehicle, if they have not already been retained by the testing station. Please also take any Annual Test Certificates you were issued at the time that the Reduced Pollution Certificate was refused to the appeal test. **Do not enclose any Notifications or Certificates with this application form.**
4. It is important that the vehicle is in the same state at the appeal test as it was when it was inspected and the Refusal Notification(s) issued. Any changes in the condition of the vehicle which have occurred since then for any reason **must** be declared on this form. They may affect the outcome of the appeal.
5. At the appeal test the reasons given for refusal of a Reduced Pollution Certificate will be considered, and an inspection made of the vehicle by an inspecting officer of the Vehicle and Operator Services Agency to determine whether the requirements of the Road Vehicle (Registration and Licensing) Regulations are fully satisfied in respect of the Reduced Pollution requirements in Schedule 2. In order to do this it will be necessary to expose the engine, exhaust system and any other special fitments that enable the vehicle to emit reduced pollution. The person presenting the vehicle for appeal must be able to tilt cabs or remove inspection panels etc as required to enable this examination to be readily carried out, as for the normal Reduced Pollution Test procedure. Vehicles presented at appeal will be required to undergo a free acceleration smoke opacity meter test and must be in a suitably well maintained condition for this to be carried out. Additionally, vehicles which normally carry dangerous goods must be presented safe for test. The inspecting officer may refuse to carry out an appeal test if the vehicle is not presented in a suitable condition.
6. If the vehicle is found at appeal to satisfy the Reduced Pollution requirements of the Regulations then a new Reduced Pollution Certificate will be issued, dated to expire at the end of a month compatible with your new Annual Test Certificate, if the

Reduced Pollution test under appeal was carried out in conjunction with an Annual Test for renewal purposes; between 22 and 23 months ahead if the appeal relates to a first Reduced Pollution Test; or between 12 and 13 months ahead if the appeal related to a second or subsequent Reduced Pollution Test not carried out in conjunction with an Annual Test.

7. If the vehicle is found at appeal not to satisfy the Reduced Pollution requirements of the Regulations another Notification of Refusal to Issue a Reduced Pollution Certificate will be issued. You must then take steps within 14 days to repair or modify your vehicle and have it retested, or re-tax your vehicle at the standard rate. Alternatively if you still feel that the refusal is unjust you may make a second appeal against the inspectors decision within 14 days, again using this form RPC3 and indicating in the appropriate box that it is a second appeal. No further appeal may be made following an unsuccessful second appeal.
